

Moving Forward

Due to the current staffing situation, here are changes to expect in the (hopefully short-term) future:

- **Seaford** and **Laurel** folks--congrats, there will be no disruptions for you! It's good to be first. :)
- **Salisbury** folks--I will be heading down straight from LeCompte Memorial. I hope to have ice stocked no later than 7:45 AM.
- **Vienna** folks--I should have the coolers and bin in place no later than 8:30 but hope to have them out by 8:15 AM.

If you arrive before the anticipated time that I'll have ice in place, please 1) bring samples in a quart ziplock with ice inside and leave in the cooler (Salisbury) or on the landing (Vienna) or 2) leave your samples in your iced cooler. Please complete the COC in Salisbury if you have to leave samples behind. I will sort out the rest.

I will collect samples in the same order as I did previously, although **I'll also be collecting in Salisbury and meeting Richard from Cambridge there**. He will bring Vienna samples to me, and I'll take your samples to Envirocorp. Accordingly, **if you are running late and drop off in Vienna, please contact Richard at 410.330.1694**. If you cannot reach Richard for some reason, please contact me. (And massive thanks to Richard for hauling Vienna samples to Salisbury and delivering chlorophyll a samples to Horn Point!)

Help with Report Card Distribution Needed

Normally, our Chesapeake Conservation Corps Volunteer distributes report cards over a span of a couple of days right after beginning the service term. This serves as a great introduction to the watershed. Due

to this year's circumstances, I need YOUR help this year with distributing report cards in your community.

If you would be willing to drop off packets of report cards to places like libraries, chambers of commerce, town halls, and businesses near where YOU live, please let me know. I won't have the packets prepared for you until late August at the earliest, but I'd like to put a plan together. You only need to introduce yourself and be prepared to speak a little about the program.
