# Meet the New Chesapeake Conservation Corps Volunteer, Amanda Anastasia

Our brand new Chesapeake Conservation Corps Volunteer, Amanda Anastasia, attended orientation in Annapolis on Tuesday and started in the office on Wednesday. She's already helping us with report card distribution and inventorying Creekwatchers items, amongst other things, and will be shadowing Lisa in September so that she can get up to speed with ice drop-offs and sample pick-

ups on Creekwatcher Mondays.



I asked Amanda a few questions so that you can begin to get to know her.

## What's the Chesapeake Conservation Corps, and what are your goals are this year as a volunteer?

The Chesapeake Conservation Corps is a one year program that provides job training and networking opportunities to young adults interested in environmentally-focused careers in the Chesapeake Bay watershed. Applicants who are chosen to participate in the program are paired with MD-based host organizations that work to protect and/or improve the quality of the Chesapeake Bay. As a volunteer with the Nanticoke Watershed Alliance, I am hoping to gain experience in water quality monitoring, community outreach, and environmental education. I am also hoping to meet tons of people that care about their local environment and to have the opportunity to chat with each of them about their own stories, cares, and concerns. When I leave the program in just under a year, I am sure I will have some great new friends and (hopefully) a better idea about where I would like to go next.

#### What drew you to the Nanticoke Watershed Alliance?

The Nanticoke Watershed Alliance really captured my attention during the CCC application process because of the variety of programs and initiatives that they are involved in. From water quality monitoring to spreading awareness to facilitating conversations between different stakeholders in the area, NWA really seems to do a little bit (or, more like a lot!) of everything. I was also very interested in working with a small non-profit, because I want to have the opportunity to be involved with all of their various programs and initiatives. Furthermore, I wanted to work with an organization that has the ability to collaborate with diverse stakeholders, because I want to be around as many different perspectives as possible, and it seems like NWA does a pretty good job with that.

## Where are you originally from, and do you have any local knowledge about the area?

I am originally from Boston, MA. I attended Washington College from 2009-2013. While in college, I spent most of my time exploring the upper eastern shore. In 2012, a friend invited me to Hurlock's annual Fall Festival, during which I experienced the charm of the lower Eastern Shore for the first time. I don't currently have a great deal of local knowledge, but I am having a great time exploring the area.

## What are your preliminary thoughts about the Nanticoke River watershed? Do you have a favorite place yet?

I think that the Nanticoke River watershed is a very beautiful area, and it is home to some of my good friends from college. I haven't been in the area long enough to really have a favorite place, but Marshyhope Creek catches my attention every time that I drive

over a bridge that crosses it. It is just so pretty!

### What are some of your favorite activities on the water?

My all-time favorite activity on the water is sailing. In fact, I owe my love for the water and my interest in environmental issues to Courageous Sailing, a sailing school on Boston Harbor that promotes life skills through their youth sailing program, where I first learned about marine debris and the impact that our trash can have on the local environment. Now an avid sailor and racer, I have had the opportunity to race in a number of distance and overnight regattas, sail on the Sea of Cortez with NOLS' Baja Coastal Sailing course, travel the Virgin Islands on the tall ship Spirit of Massachusetts, and spend a long weekend sailing the Chesapeake Bay. In addition, I also enjoy kayaking and swimming. I am terrible at fishing and have never been able to stand on water skis, but I still believe that there is no such thing as a bad day on the water.
