## Tom Tyler Nature Trail

Congrats to our Chesapeake Conservation Corps Volunteer Tyler Walston for his successful "All Hands on Deck" Tom Tyler Trail project. On Friday, June 14, a large group of CCC Volunteers, Chesapeake Bay Foundation volunteers, staff, and others helped cut back growth on existing



trails, removed debris, built new bridges, installed new signage, and helped cut new paths. Following

the conclusion of the service project, the trail was rededicated in Tom Tyler's honor. (Tom Tyler was an NWA board member and employee of Chesapeake Forest Products. He originally designed the trail as a demonstration forest to showcase Atlantic White Cedar and forestry Best Management Practices.)

This trail is just off of Route 50. Heading west on Route 50, take the last right before the Nanticoke Memorial Bridge onto Old Bradley Rd. A few miles on the left, you'll find the Tyler Trail parking area.

As with many ambitious projects, we weren't able to finish everything that needs to be done on June 14. We'll likely be setting some additional service project dates and will let you know about them. If you'd like to read more
