Lastly, I will be on vacation from May 20-May 28, so if you need anything during that time period, please contact Amanda or Lisa.



### Creekwatching Tips

There are still a few issues that pop up from time to time, so I'm including a few reminder tips that you should read before going out next weekend.

1. Please remember to write the amount of water filtered on the foil. All

information on the foil should be on the same side.

2. Please remove the snack baggie from the quart baggie prior to depositing your chlorophyll a samples in the dry ice cooler. You can dry out and reuse your quart baggies.
3. Please label your nutrient bottles, Whirl-Paks, and foil with the site code and sampling date.
4. On the Chain of Custody form for nutrient and bacteria samples, PLEASE LEAVE the Lab ID column (far left) BLANK. ONLY Envirocorp uses this line. You should start recording your information in the DESCRIPTION column.
5. Blanks and duplicates will resume next sampling period, but we will skip dupes/blanks during the May 18-19 Sampling Period due to staffing. See below.

Blanks are distilled water samples. Duplicates are regular water samples. Blanks and dupes should be taken at ONE of your sites only, and you should rotate during the season. You should take both a nutrient and a bacteria blank/dupe.

## May 18-19 Sampling Period

Amanda will be away during the May 18-19 sampling period, so there will be a few changes:

1. We will not be taking dupes/blanks during this sampling period since Amanda will not be able to help the lab with processing.
2. Ice will be late at the Salisbury and Vienna locations. I will be meeting Lisa in Salisbury with dry ice at 7:45 AM. No one drops off early in Vienna, but for those of you who drop off at Salisbury, please bring a small amount of ice in a baggie and just place your CA samples in the regular cooler. We'll move the sample to the dry ice cooler when we arrive. I will be in touch with those of you who drop off early in Salisbury just ahead of this sampling period to remind you that we'll arrive late.
